EDITORIAL

Audiobooks in India



From primarily serving the visually impaired when they started, audiobooks are a rapidly growing, important segment of the publishing market worldwide. The global audiobook market, estimated by some studies at over US\$5.3 billion, is growing at an impressive rate of 20% per annum, though it is only 6–7% of

the broader book market. This indicates the increasing popularity of audiobooks as a convenient way to enjoy content by consumers all over the world.

India has a rich oral storytelling tradition. Since centuries our religious and other stories have been transmitted orally. The Indian audiobook market has been the fastest growing market after the US and China. Many Indians tried the service during the Covid pandemic and the interest has remained thereafter, increasing the adoption levels.

Responding to the readers' demands and going beyond converting written books into audiobooks, authors have now started producing audio-only books or audio-first books. Besides, similar to global trends, Indian audiobooks are also seeing the involvement of celebrities and well-known voice artists, which add appeal and credibility, thus attracting more customers. Several global audiobook platforms have expanded their presence in India, offering a wide range of audiobooks across various genres and languages. Additionally, a large number of local players and publishers provide audiobooks in a variety of titles in languages such as English, Hindi, Tamil, Telugu, Bengali, Marathi and many more, further fuelling the growth of audiobooks in India.

However, raising awareness and pricing remain the biggest challenges for the sector. Despite India being one of the largest countries to consume audiobooks, the per capita spends on audiobooks has been low. This has led to creative, multi-model revenue strategies which include ad-monetisation as well as micro-payments. With the increasing adoption of smartphones and digital infrastructure and low telecom/data prices, the Indian audiobook market is poised for significant growth in the coming years.

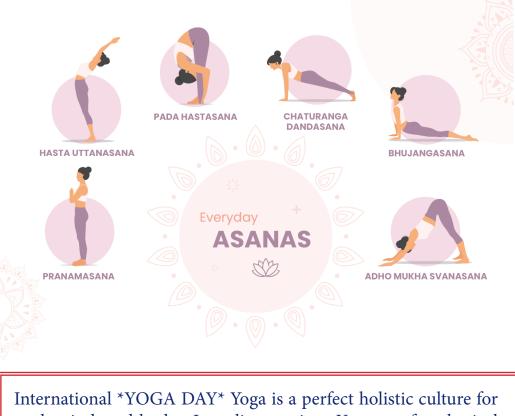
Audio Publishers Association, USA has reported a growth of 9% annually. Organising the first of its kind conference in New York city on 10th September 2024.
